- music

When you are writing your will you may see some new words which refer to the kind of gift you can leave to a registered charity like St George's Hall Charitable Trust;

a pecuniary gift – this is a gift of a fixed sum of money

a specific gift – we are not always able to accept noncash donations, if you would like to do this please contact us to discuss

a residuary gift – this is a share of whatever is left in your will after all debts have been settled and other gifts made

You should discuss with a qualified solicitor which type of gift you would like to make.
